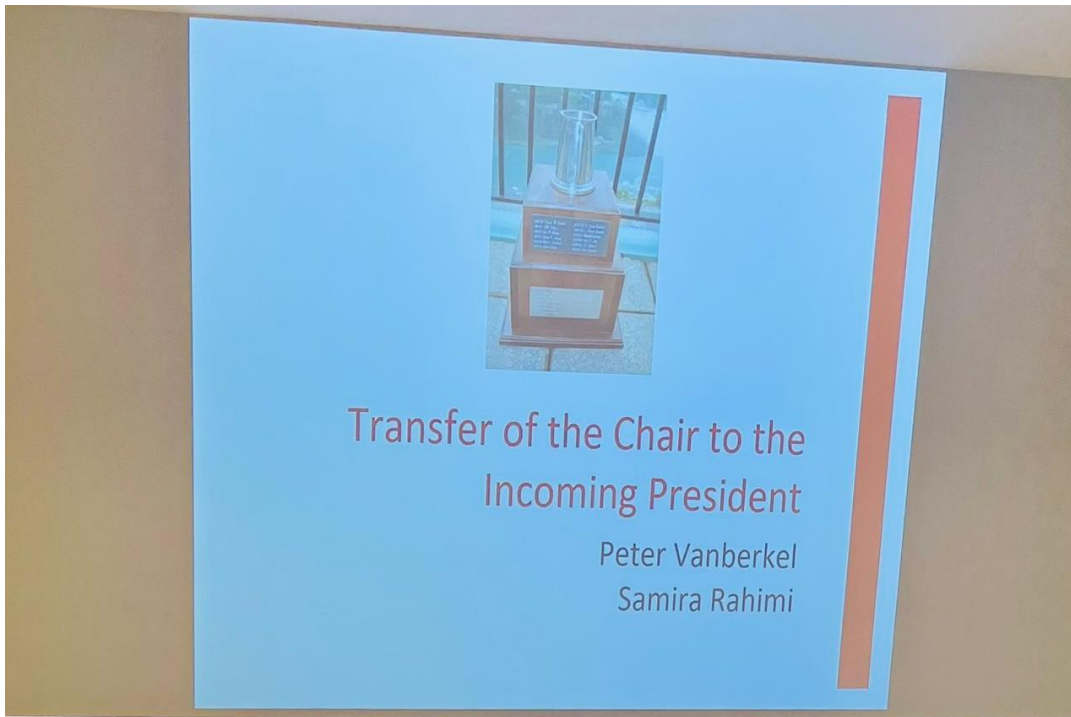

### FUNDING OPPORTUNITIES

#### Traveling Speakers Program (TSP)

The Traveling Speakers Program (TSP) enables local sections to bring OR practitioners and researchers in Canada as speakers to their local events. In order to keep costs in line while maximizing the CORS National profile, CORS sponsorship will be limited to 50% of the total expenses, up to a maximum of \$500 per speaker or \$1000 for a single event (conference, workshop). Other expenses can be covered by the local section. The program of the event must acknowledge the contribution of CORS. The president of the local section must contact the TSP Coordinator to obtain approval for funding at least one month in advance of the event date. Payment will be made by the CORS Treasurer upon receipt of the Expense Form (WORD) or the Expense Form (PDF).

## INFOR JOURNAL

### Update on the Impact Factor of INFOR: Information Systems and Operational Research

Clarivate recently released the 2022 journal impact factors. I am happy to report the increase in the Impact Factor (IF) of INFOR from 1.05 to 1.3.

Since 2019, the impact factors of all the journals have been affected by a change in how a journal's IF is calculated. The 2020–2021 IF for the majority of journals across all disciplines were higher than the trend following the inclusion of Early Access content (online publication before a paper is assigned to an issue) in the Journal Citation Reports. As a result, INFOR's 2020 impact factor increased to 1.59 (from 0.97 the year before). According to Clarivate, some journals were onboarded to the new impact factor in 2020 while the rest in 2021. While Clarivate did not indicate which journals were in each group, we believe that INFOR's IF calculation changed in 2020. Thus, while we were pleased to see INFOR's IF increase to 1.59 in 2020, this increase was overly positive, and the subsequent drop to 1.05 was expected following the adjustment in the IF calculation. We are happy to see the increase of INFOR's 2022 IF to 1.3 and we believe this is now more representative of the IF trend.

Prof. David Simchi-Levi and Prof. Tinglong Dai recently wrote a note to the INFORMS community on the impact of Clarivate's IF calculation change which provides a comprehensive explanation of the change and impact on the journals [1]. You can also refer to [2] for more details regarding the calculation of IF and the recent changes.

Besides the newly reported impact factor, all of INFOR's quality indicators are at all time high. Article downloads have increased by 92% since 2019. Article citations have increased by 25% since 2019. We are also happy to mention that the median time for first decision is currently 97 days (a decrease from ~200 days in 2019).

Finally, I would like to thank all of INFOR's area editors, associate editors, and referees for all their efforts to increase the quality and stature of INFOR in the community. I also would like to thank the authors for choosing INFOR as outlet for their research.

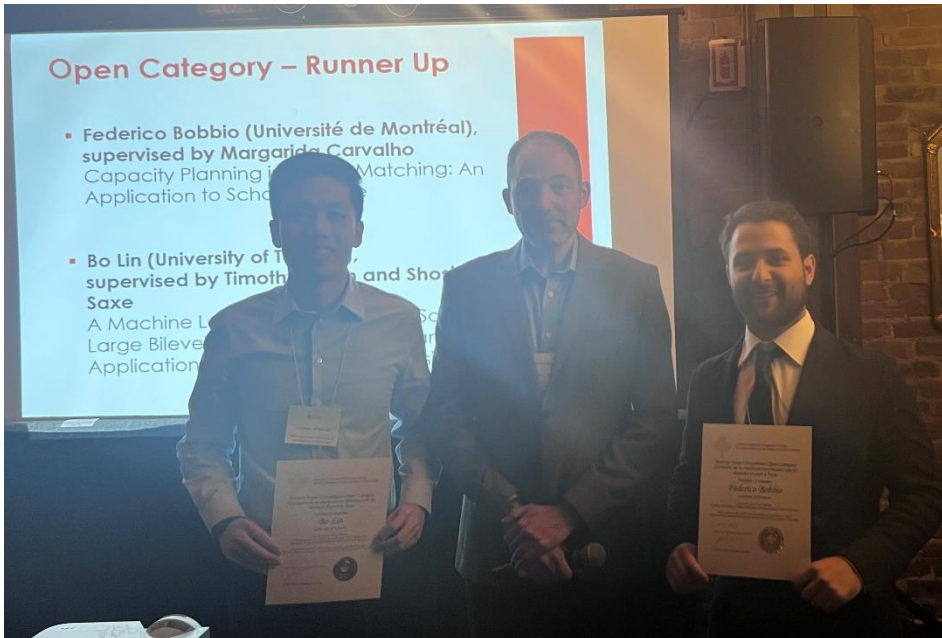

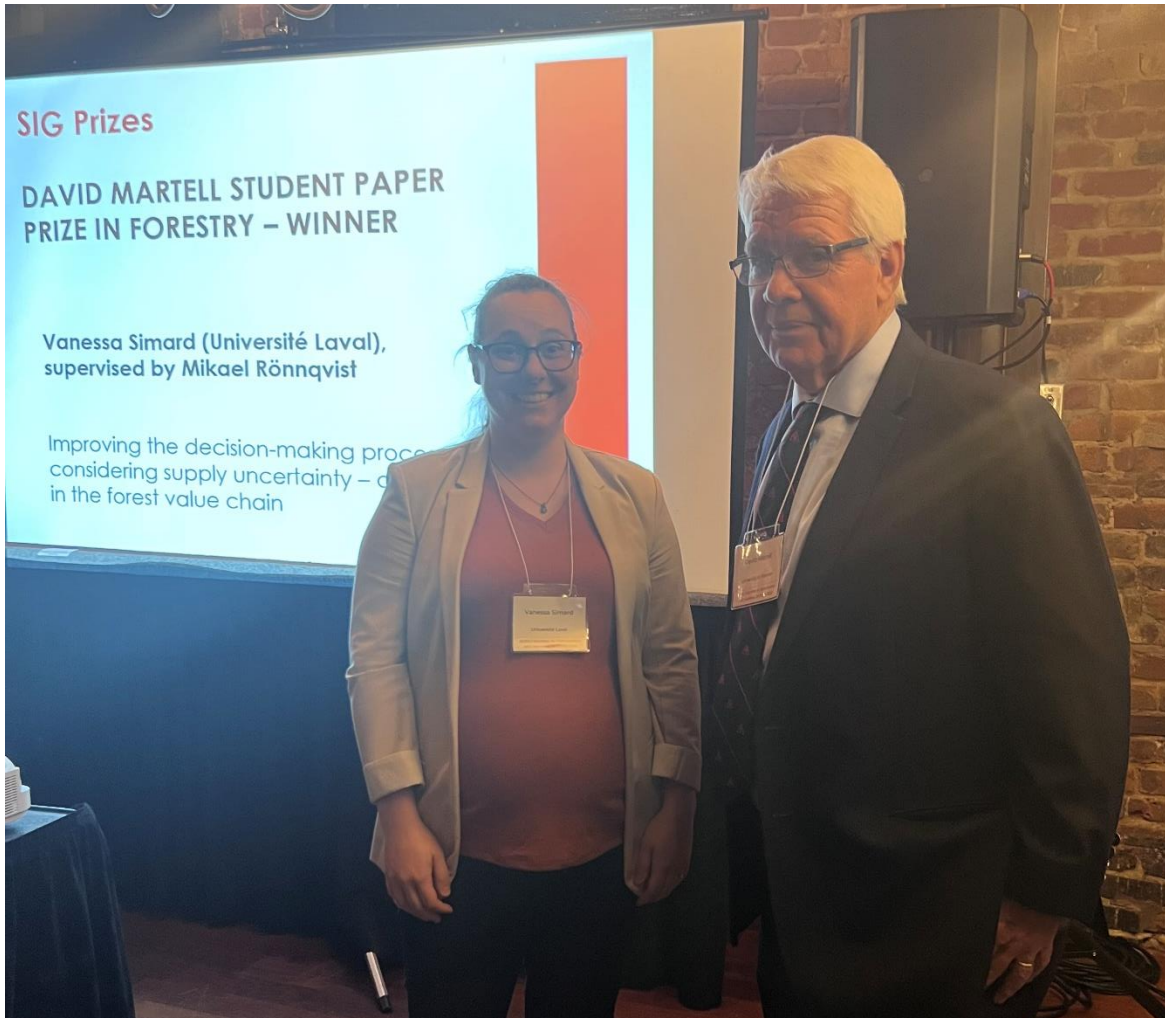

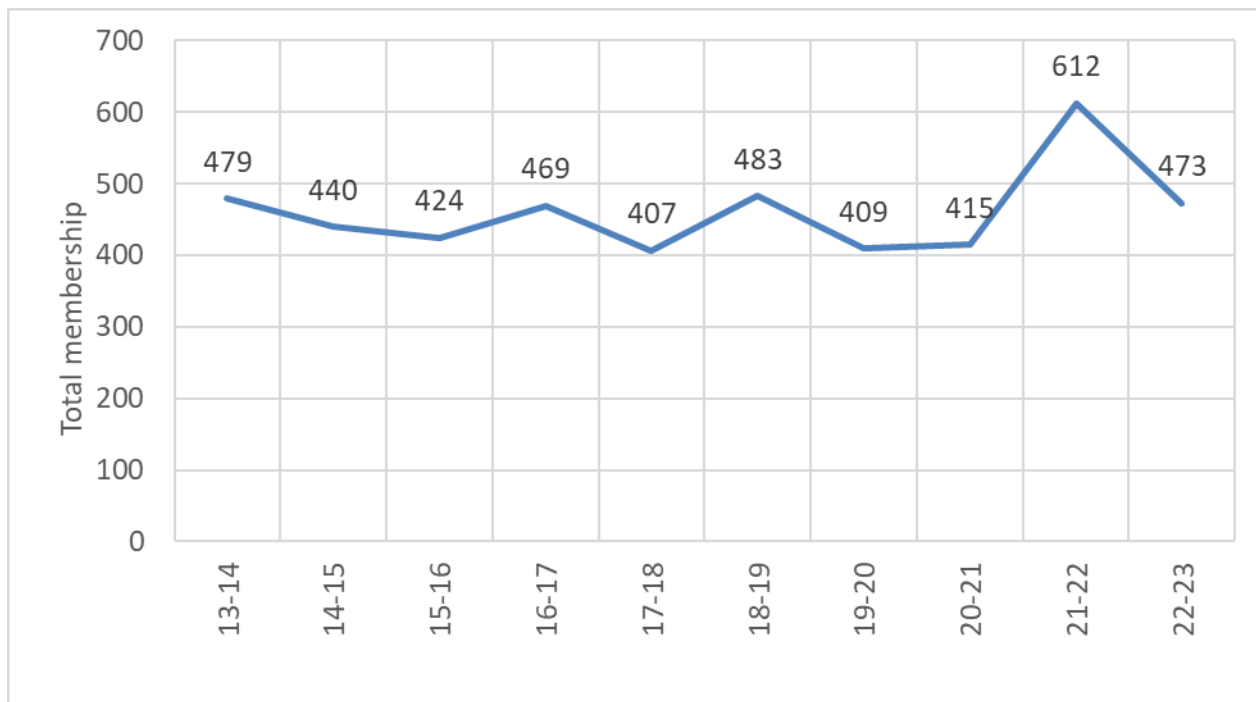
## 2022–2023 CORS MEMBERSHIP REPORT

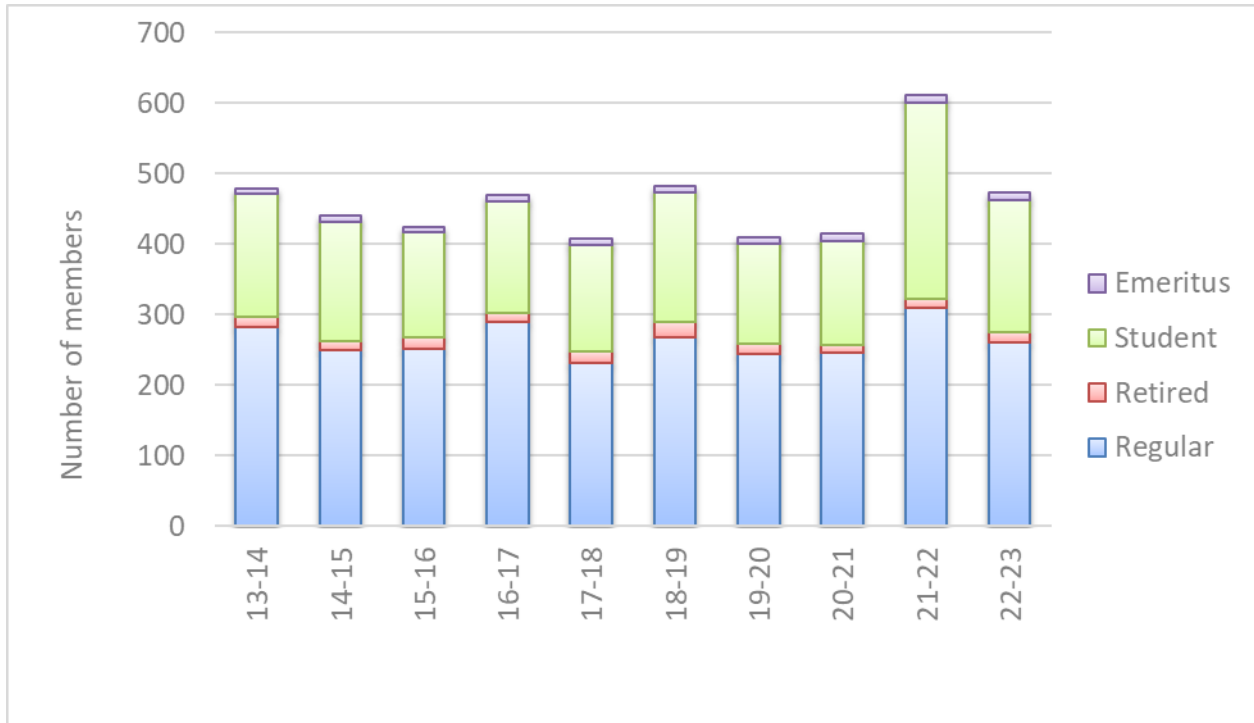

### *CORS Membership 2013–2023*

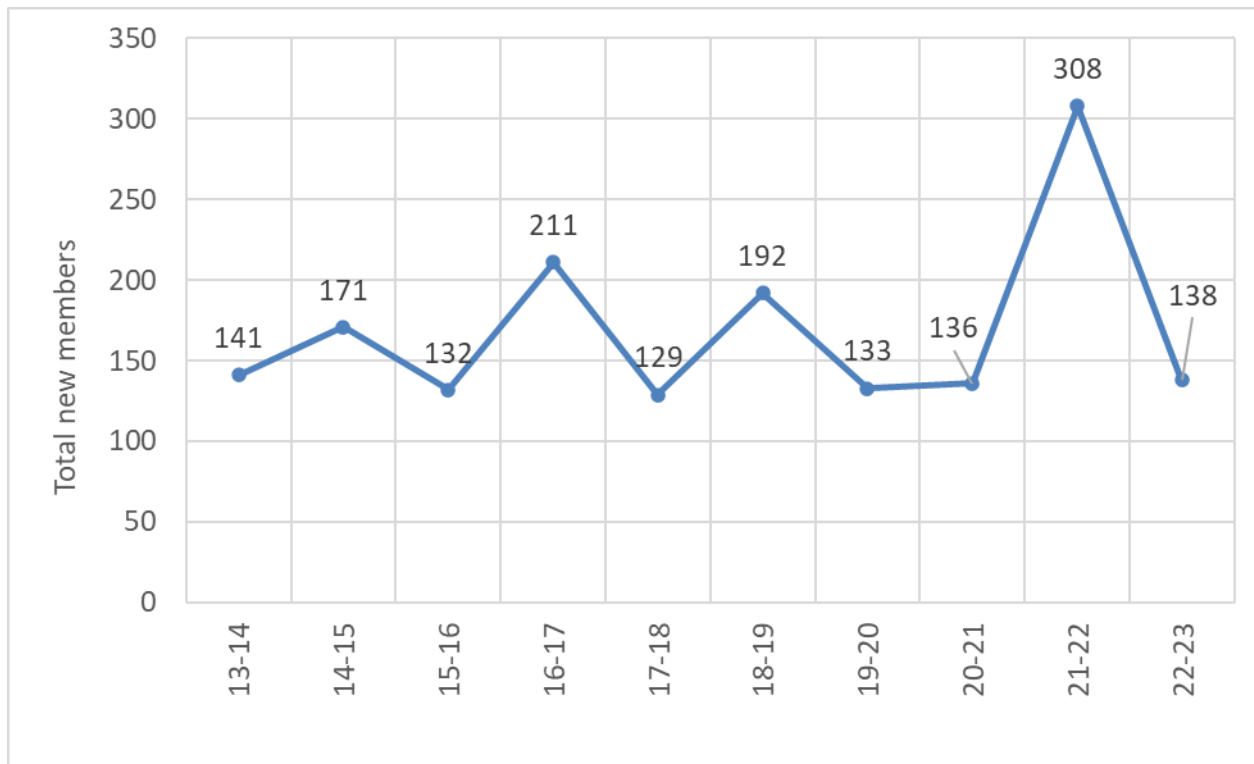




### ***CORS Membership by Member Type 2013–2023***
